Online Registration Deadline

Online registration will close September 19, 2023. Onsite registration will be available September 21-22, 2023, and must be paid via credit card (VISA, MasterCard, Discover or AMEX).

Online Group Registration

Group discounts are not available for this event.

PostCon Workshops

Registration for main conference programming is required to participate in PostCon workshops. PostCon workshops require an additional, **non-refundable** registration fee.

Payment Options

- Credit Card (VISA, MasterCard, Discover, or AMEX)
- Check the check payment option will be available online beginning March 31, 2023, through August 30, 2023. Checks must be received in CAEP offices within 21 days of online registration. If the final check payment is not received by September 19, 2023, the registration(s) will be automatically canceled, and a new onsite registration will be necessary (at the onsite registration price).

Onsite registration must be paid with a credit card (VISA, MasterCard, Discover or AMEX).

Please use the event confirmation ticket (received via Eventbrite) as the invoice for your check. Check payment(s) must include the **registration order number** and **attendee name(s)** on the memo portion of the check. Please include a copy of the event confirmation ticket when mailing the check payment.

Confirmation

Cancellation and Refunds

Cancellation and/or refund requests must be received in writing via events@caepnet.org no later than August 30, 2023. No refunds will be granted for requests received after this date. CAEP regrets that refunds will not be given for no-shows.

Cancellation and/or refund requests must be made in writing and cannot be made in person or over the phone.

Conference registration fees may be applied to a future CAEP conference or transferred to an individual within the same organization (see Substitutions below).

According to the following schedule, refunds are disbursed by credit card or check to the original issuer of payment no later than six weeks following the conclusion of the conference.

If a CAEP conference is cancelled due to inclement weather or other acts of nature as set forth herein, every attempt will be made to reschedule the event and your registration fee will be applied to the rescheduled event date. If CAEP is unable to reschedule the event, your registration fee will be refunded or applied to the next CAEP Conference. Any travel expenses that may have been incurred cannot be refunded under any circumstances. If the CAEP event is held, but weather conditions (whether forecasted or actualized) prohibit you from traveling, CAEP will not provide a refund for your registration fee.
